**I. Call to Order and Determination of Quorum – Jason Moses, Chairman:**

Jason Moses, IBOG Chairman, called the meeting to order at 8:00 a.m. A quorum was established.

**II. Consent Agenda – Jason Moses, Chairman:**

A motion to approve the minutes of the October 19, 2012 Board meeting was made by Linda Vinson, seconded by Chris Stevens and approved. A motion to make revisions to IBOG Policy No. H-21 on Faculty Evaluation, Promotion, Tenure, Sabbatical (Part of Faculty Personnel Policy) Section 5.4.a was made by Linda Vinson, seconded by Sue Richardson and approved. The revised rule will be available to the public for a 30-day comment period. Providing no substantive comments are received, the final policy is approved.

**III. Audited Financial Report for FY 2012 – Dr. Cotroneo:**

Mike Hager, Manager – Assurance, Accounting and Business Taxation for Hayflich Grigoraci, presented the Board copies of the College's audited Financial Statements as of and for the years ended June 30, 2012 and 2011 and Independent Auditors' Reports along with a October 29, 2012 letter from the auditors. A schedule of Key Financial measures was also discussed. Following discussion, a motion to officially receive the documents was made by Sue Richardson, seconded by Mark George and approved.

**IV. President's Report – Dr. Keith Cotroneo:**

Dr. Cotroneo made the following announcements:

- Due to the efforts of Cory Payne, Military and Veterans Program Manager at Mountwest, the college has just been named the Best Two-Year College for Veterans in the Nation by *Military Times*.
- Beacon Grant – President Cotroneo is pleased with the progress of the grant and the number of students involved in the program.
- Enrollment for the Fall 2012 semester appeared to have dropped due to a number of students being documented during the Summer term rather than the Fall term, as was the case in previous years.
- Jean Chappell, Dean of Allied Health & Life Sciences, will be leaving the college in January 2013 for a new position at Cincinnati State Technical & Community College.
- Consortium – A meeting with the public school superintendents was held and progress has been made.
- The College was successful in securing a \$110,000 grant from the WV Community & Technical College System for the Mountwest Café'.
- Facilities Update - The outside of the headquarters building will be painted Spring 2013. The Café' is now in a position to begin offering hot food choices in January 2013. The lease on Third Avenue which formerly housed the CCI will end in January 2013.
- Jason Moses provided the Board with an update related to the Board of Governors Association.
- Kimberley Patrick provided the Board with an update related to activities of the Advisory Council of Students and the Student Government Association.
