## 1. Tour of the Center for Culinary Arts:

Todd Cox, Assistant Professor in the Culinary Arts program, and Dr. Steven Brown, Dean of the Career and Technical Division, provided Board members and guests with a tour of the Center for Culinary Arts.

### 2. Call to Order and Determination of Quorum – Jeffrey Goad, Chairman:

Jeffrey Goad, IBOG Chairman, called the meeting order at 8:38 a.m. A quorum was established.

## 3. IBOG Chairman Report - Jeffrey Goad, Chairman:

President Cotroneo indicated Jerry Brienza accepted a position out-of-state and thus had resigned from the Institutional Board of Governors. Additionally, Bill Bissett resigned due to his teaching status at Marshall University. One name has gone forward to Governor Justice for a suggested appointment to the Board. Nominations for the other vacant seat are welcome.

### 4. Consent Agenda – Jeffrey Goad, Chairman:

A motion was made by Cathy Burns and seconded by Jeremy Blackshire to approve the minutes submitted for the November 16, 2017 meeting. The motion was approved.

## 5. President's Report - Dr. Keith J. Cotroneo, President:

- HLC Accreditation Update The draft HLC Accreditation Report included four areas that
  were noted as the standards being met but with concerns, mostly dealing with
  assessment. Faculty committees have been formed to work in each of these areas. In
  four years there will be another review by the HLC, updating progress that has been
  made in addressing the concerns. The next step in the accreditation process will occur
  in February when the committee recommendations are sent to the HLC Institutional
  Actions Council. This Council will make a final recommendation to the HLC relating to
  the college's institutional accreditation.
- The WV Legislature is currently discussing a proposal to create a free community and technical college tuition bill. As the proposal currently stands, WV residents would have to first apply for federal financial aid and then any tuition not covered by financial aid would be eligible to be covered under the free tuition proposal.
- An Alliance for Economic Development in southern WV has been created. Dr. Steven Brown recently represented Dr. Cotroneo at a press conference announcing the alliance.
- The Spring 2018 academic term begins January 18, 2018.
- Higher Education Day at the legislature is scheduled to be held January 23, 2018.
- Public higher education institutions in WV are no longer required to pay an annual HERA (Higher Education Resource Assessment) fees.
