All board members received 30 minutes of training credit for the presentation. Overall, Mountwest is performing well financially and has one of the healthiest CFI scores in the state.

Additionally, the board briefly discussed tuition caps. Dr. Baker gave the board a review of Bridgevalley's decent to remove the tuition cap last year. We will continue to monitor other colleges before making a decision.

Dr. Baker presented his President's report, highlighting recent grants, college wide professional development, college events, non-credit program highlights, facilities, and legislative topics. 



### **Cash Report:**


The attached Cash Operating Budget Report is for January 2024 the 7th month of the 2024 Fiscal Year. The target for the year is 58% for revenue and expense if activity was spread equally over 12 months. Revenue is at 92% which is above target, and expenses are currently at 56%, which is slightly under the target.




Cash at the end of January 2024 was approximately 16% higher than January 2023, for a \$1,843,007 difference. The number of days cash on hand in January 2024 is 476, and as of January 2023, it was 455 days, an increase of 21 days.




Supplies and Other expenses for January 2024 were \$394,360 which is higher compared to \$239,342 in January 2023. The YTD Supplies and Other Expenses for FY24 are \$1,629,224 compared to \$1,475,843 for FY23, which is an overall increase of \$153,381.



Salaries and Benefits for the month of January 2024 were \$451,170 and \$125,057 respectively, compared to \$420,033 and \$108,726 in January of last year. The YTD Salaries and Benefits for FY24 are \$3,597,849 and \$887,989 compared to \$3,470,153 and \$799,406 for FY23, for an increase of \$127,695 and \$88,583 respectively.

- Enrollment
  - In January we reported a VERY conservative 9% expected growth. After drops, we are actually up a shocking 22%!

## • College Updates

- The Mountwest Foundation is filing paper work so it can hold grants awarded to the college. This would allow some spending flexibility, which is proving necessary while working with community partners.
- A \$350,000 state grant in process to create a demonstration kitchen and filming equipment at Culinary Center. Initiated by state Super Intendent's office.
- Candidates for Dean interviewing this week.

## • Workforce Development Highlights

- Free Social Media class (including micro-credential) offered as marketing for Digital and Technical Marketing. 30 enrolled, with a wait list.
- Hiring Director for Apprenticeship, please send us great candidates!
- Productive meeting with Electrician program faculty. Student recruiting session pending.
- Awarded an additional \$30,000 for AIM grant (IT related), in addition to the \$100,000 increase we reported last month.
- Awarded state grant for Physical Therapy Aid program, a short-term program leading to Physical Therapy Assistant in an apprenticeship model. Created in partnership with Generations Physical Therapy
- Virtual Reality training option for Paramedic has been demonstrated. Many community members were invited, and a community approach is being pursued. Organized by community member Todd Shell.

• Swope Construction awarded bid for Cyber Center and will begin work this month.

### • Legislative Topics

- Apprenticeship bill is progressing. It is designed to support the apprenticeship innovations we are developing.
- State budget very much in development. Worse case scenario seems to be a flat budget.
